- Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at last seventy five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Interested bidders may obtain further information from the Provincial Government of Misamis Oriental – Bids and Awards Committee thru the BAC Secretariat at *the Procurement Unit, Capitol building, Cagayan de Oro City* and inspect the Bidding Documents at the address given below from **8:00 a.m. to 12:00 and 1:00 p.m. to 5:00 p.m.**

A complete set of Bidding Documents may be acquired by interested Bidders on **[March 14, 2019 to April 02, 2019; 12:00NN]** from the address below upon submission of Letter of Intent and payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement system (PhiGEPS) and the website of the Procuring Entity (if applicable), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

- There will be a Pre-Bid Conference on **[March 21, 2019; 10:00 a.m.]**, at the ***MISORTEL, Conference Room, Antonio Luna St., Cagayan de Oro City***

Bids must be delivered to the address below on or before **[April 02, 2019 1:30p.m.]**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.p

- Bid opening shall be on **[April 02, 2019; 2:00p.m.]** at the ***MISORTEL, Conference Room***. Bids will be opened in the presence of the Bidder's representative who chooses to attend at the address above. Late bids shall not be accepted.
