Delivery of the Goods is required stated above. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested Bidders may obtain further information from Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol building, Cagayan de Oro City and inspect the Bidding Documents at the address given below from [8:00-12:00 NN, 1:00-5:00 PM].

5. A complete set of Bidding Documents may be purchased by interested Bidders on **[September 26, 2019 to October 3, 2019; 8:00-12:00 NN, 1:00-5:00 PM]** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before **October 3, 2019; 1:30PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **[October 3, 2019; 2:00PM, at the Misortel Office, Conference Room, Antonio Luna St., Cagayan de Oro City]**. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address above. Late bids shall not be accepted.

7. The Provincial Government of Misamis Oriental/ Bids and Awards Committee reserves the right to accept or reject any bid, to annul the bidding process and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
