Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

3. Interested bidders may obtain further information from the Provincial Government of Misamis Oriental – Bids and Awards Committee thru the BAC Secretariat at *the Procurement Unit, Capitol building, Cagayan de Oro City* and inspect the Bidding Documents at the address given below from **8:00 a.m. to 12:00 and 1:00 p.m. to 5:00 p.m.**

A complete set of Bidding Documents may be acquired by interested Bidders on **[January 14, 2021 to January 21, 2021; 12:00NN]** from the address below upon submission of Letter of Intent and payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement system (PhiGEPS) and the website of the Procuring Entity (if applicable), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

4. Bids must be delivered to the address below on or before **[January 21, 2021 1:30p.m.]**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.p

Bid opening shall be on **[January 21, 2021 2:00p.m.]** at the ***Bids and Awards Committee, Conference Room, 2nd Floor Capitol Building, Cagayan de Oro City***. Bids will be opened in the presence of the Bidder's representative who chooses to attend at the address above. Late bids shall not be accepted.

5. The *Provincial Government of Misamis oriental/ Bids and Awards Committee* reserves the right to accept or reject any bid, to annul the bidding process and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
