3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de Oro City** and inspect the Bidding Documents at the address given below during **[8:00AM-5:00 PM]**.

A complete set of Bidding Documents may be acquired by interested Bidders on **[October 06, 2022 to October 13, 2022; 8:00-5:00 PM]** from the given address and website(s) below Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de Oro City and upon payment of the

applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **[Php500.00]**. The Procuring Entity shall allow the bidder to present its proof of payment.

6. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City** on or before **October 13, 2022;10:00AM**. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on **October 13, 2022; 10:30AM** at the given address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
