The Procuring Entity shall allow the bidder to present its proof of payment.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City on or before November 03, 2022;10:30AM. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
