


The Procuring Entity shall allow the bidder to present its proof of payment.
- The Provincial Government of Misamis Oriental will hold a Pre-Bid Conference on November 03, 2022;10:30AM at the Bids and Awards Committee Office, 2nd Floor Capitol Building, Cagayan de Oro City, which beopen to prospective bidders
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City on or before November 17, 2022;10:00AM**. Late bids shall not be accepted.
