


The Procuring Entity shall allow the bidder to present its proof of payment.
- The Provincial Government of Misamis Oriental will hold a Pre-Bid Conference on November 03, 2022;10:30AM at the Bids and Awards Committee Office, 2nd Floor Capitol Building, Cagayan de Oro City, which beopen to prospective bidders
- Bids must be duly received by the BAC Secretariat through manual submission at the office address Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City on or before November 17, 2022;10:00AM. Late bids shall not be accepted.

Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
