The Procuring Entity shall allow the bidder to present its proof of payment.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City** on or before **December 01, 2022;10:00AM**. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on **December 01, 2022; 10:30AM** at the given address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
