The Procuring Entity shall allow the bidder to present its proof of payment.
- 6. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Bids and Awards Committee Office, Conference Room, 2<sup>nd</sup> floor, Capitol Building, Cagayan de Oro City on or before <u>December 01, 2022;10:00AM</u>. Late bids shall not be accepted.**
- 7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 8. Bid opening shall be on <u>December 01, 2022; 10:30AM</u> at the given address **Bids** and Awards Committee Office, Conference Room, 2<sup>nd</sup> floor, Capitol Building, Cagayan de Oro City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
