The Procuring Entity shall allow the bidder to present its proof of payment.
6. The **Provincial Government of Misamis Oriental** will hold a Pre-Bid Conference on **May 04, 2023;10:30AM** at the Bids and Awards Committee Office, 2nd Floor Capitol Building, Cagayan de Oro City, which be open to prospective bidders

9. Bid opening shall be on **May 18, 2023; 10:30AM** at the given address **Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
