
Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Interested bidders may obtain further information from **Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de Oro City** and inspect the Bidding Documents at the address given below during **[8:00AM-5:00 PM]**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **[June 15, 2023 to June 21, 2023; 8:00-3:00 PM]** from the given address and website(s) below Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de Oro City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **[Php 500.00]**. The Procuring Entity shall allow the bidder to present its proof of payment.

6. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Bids and Awards Committee Office, Conference Room, 2<sup>nd</sup> floor, Capitol Building, Cagayan de Oro City** on or before **June 22, 2023;10:00AM**. Late bids shall not be accepted.
