- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from <u>Bids and Awards Committee</u> thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de <u>Oro City</u> and inspect the Bidding Documents at the address given below during [8:00AM-5:00 PM].
- A complete set of Bidding Documents may be acquired by interested Bidders on [June 09, 2023 to June 14, 2023; 8:00-3:00 PM] from the given address and website(s) below Bids and Awards Committee thru the BAC Secretariat at the Procurement Unit, Capitol Building, Cagayan de Oro City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Php1,000.00]. The Procuring Entity shall allow the bidder to present its proof of payment.
- 6. Bids must be duly received by the BAC Secretariat through manual submission at the office address Bids and Awards Committee Office, Conference Room, 2nd floor, Capitol Building, Cagayan de Oro City on or before <u>June 16, 2023;10:00AM</u>. Late bids shall not be accepted.
- 7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 8. Bid opening shall be on <u>June 16, 2023; 10:30AM</u> at the given address **Bids and Awards Committee Office, Conference Room,** 2nd **floor, Capitol Building, Cagayan de Oro City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Provincial Government of Misamis Oriental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
